Current Research Projects

My current research builds on my biographical dictionary of enslaved Black people in the Maritimes. I am currently working on a book that will focus on 7 or 8 enslaved individuals and their lives in both the United States and Colonial Canada. I will be focusing on individuals who have a fair amount of documentation about their lives, but still require a great deal of historical reconstruction and imagination to understand their lives.

I recently completed six entries for the *Dictionary of Canadian Biography*. These entries are exclusively about enslaved Black people and include Diana Bastian, Statia, an unnamed teenage boy, Nancy, Isaac Willoughby, and Lydia Jackson.

I recently completed a book chapter on the *Somerset* decision and how it impacted Colonial Canada. I hope to present it to the Stokes Seminar. It will be published in a collection edited by Matthew Mason and David Waldstreicher.
